The journal was founded in 1949. Afterwards it was subdivided into a series of periodical professional journals Issues of phonetics, Etymology, Slavic linguistic atlas, Speech culture matters, Russian language today) dedicated to matters of current importance concerning theory and history of Russian language with publications of foremost Russian and international linguists.

In 2013 the journal recommended being published tree times a year under the name of "Trudy Instituta Russkogo Yazyka imeni V.V. Vinogradova" (Proceedings of the V.V. Vinogradov Russian Language Institute).

Russian language, orthography, phonetics and phonology, morphology, syntax, pragmatics, semantics, etymology, dialectology, corpus linguistics.

The journal contains original articles, conference reviews, linguistic expedition reports, book reviews and surveys, as well as materials concerning the history of Russian linguistics.

Trudy Instituta Russkogo Iazyka imeni V.V. Vinogradova (Proceedings of the V.V. Vinogradov Russian Languages Institute) publishes materials on different study of Russian linguistics. Its content is formed by articles covering the following branches of research: linguistic source studies and history of literary Russian, Russian dialectology and linguogeography, etymological research based on Slavic and other Indo-European languages, phonetics and phonology of Russian language, dynamic processes in modern Russian, speech culture matters and codifying norms.

The journal accepts manuscripts which have not been previously published. All articles are published in Russian or in English. If you write your paper in English, you may use either American or British English, but not a mixture of these. Authors writing in their non-native language are advised to have their articles thoroughly edited by professionals with native-level proficiency in that language prior to submission.

Before submitting an article, all authors are strictly advised to familiarize themselves with the <u>Instructions for Contributors</u>:

1. Metadata

The metadata of the article include author's name, title, abstract and key words. The names of authors must be listed in the alphabetical order above the title. For each author indicate his or her affiliation. The abstract must be of 150-250 words, it should be self-contained (no abbreviations, footnotes, or incomplete references) for use in abstracting journals and databases. The abstract must be informative and well-structured. Papers should contain 5-10 key words provided below the abstract. The list of key words must be informative and specific to the content of the article.

2. General Manuscript Formatting Guide

We ask our authors to follow the principles of this style guide while preparing their papers for publication.

- 1. Your manuscript should be typeset using Microsoft Word and a 'standard' font, preferably 12-point Times New Roman (10-point for footnotes), with a line spacing of 1.5 and a first line indent of 0.7 cm on each paragraph. If you use a non-standard font, please attach the font file to your message as well as a copy of your paper in PDF format.
- 2. The article generally should not exceed 40 000 characters (spaces included), although exceptions are possible.
- 3. Please, use footnotes with a continuous numbering.
- 4. The bibliography should be put into alphabetical order and placed at the end of the document. References within the text of the article should be placed into square brackets with, in the general case, indication of the author's name, year of publication and, if necessary, pages (see below).
- 5. Please, include a list of the abbreviations and acronyms you use in your article. The list should be placed at the end of the document.
- 6. Language units and illustrations cited in the article should be italicised. To indicate meaning, please, use English single quotes ('meaning'), also use French quotation marks (angle quotes, guillemets) for long citations («a long citation»), English double quotes for citations within citations («a long citation "a citation within a citation"»).

- 7. Any illustrations (maps, images, photos) should be of good quality, in JPEG format with a resolution of at least 300 dpi and the width of at least 13 cm.
- 8. Place the detailed information about the article's author (s) (name, affiliation, academic position, mailing address, electronic address, phone number) at the end of the document.

3. Bibliography

The bibliography should be put into alphabetical order and placed at the end of the document. For abbreviated titles, please, first indicate the abbreviation. If you submit your article in Russian, the bibliography should follow the Russian National Standard for Bibliography Items. Please note that in this case the name of the publisher and of the editor (for collections of articles, dictionaries etc.), as well as the name of the research institution or university (for dissertations) must not be omitted.

The titles in a non-roman alphabet should be romanized and translated into English. The romanization should conform to the BSI romanization principles (a translateration standard approved by the State Department of the United States of America).

Also, please consult the journal's Publication Ethics and Publication Malpractice Statement.

Trudy instituta russkogo yazyka imeni V.V. Vinogradova (Proceedings *of* the V.V. Vinogradov Russian Language Institute) is a peer-reviewed journal. Every submitted article is evaluated by at least two members of the advisory board and, if needed, by other reviewers with relevant experience and expertise (double-blind peer-review). Within a month, the author receives the editors' response with their decision and a list of any changes needed for the article to be accepted for publication.

A **double-blind peer review** method is mandatory for processing of all scientific manuscripts submitted to the editorial stuff of "Trudy Instituta Russkogo Yazyka imeni V.V. Vinogradova" (Proceedins of the V.V. Vinogradov Russian Language Institute). This implies that neither the reviewer is aware of the authorship of the manuscript, nor the author maintains any contact with the reviewer.

- 1. Members of the editorial board and leading Russian and international experts in corresponding areas of linguistics perform peer reviews. Editor-in-chief, deputy editor-in-chief or science editor choose readers for peer review. We aim to limit the review process to 3-4 weeks, though in some cases the schedule may be adjusted at the reviewer's request.
- 2. Reviewer has an option to abnegate the assessment should any conflict of interests arise that may affect perception or interpretation of the manuscript. Upon the scrutiny, the reviewer is expected to present the editorial board with one of the following recommendations: to accept the paper in its present state; to invited the author to revise their manuscript to address specific concerns before final decision is reached; that final decision be reached following further reviewing by another specialist; to reject the manuscript outright.
- 3. If the reviewer has recommended any refinements, the editorial staff would suggest the author either to implement the corrections, or to dispute them reasonably. Authors are kindly required to limit their revision to 2 months and resubmit the

- adapted manuscript within this period for final evaluation.
- 4. We politely request that the editor be notified verbally or in writing should the author decide to refuse from publishing the manuscript. In case the author fails to do so within 3 months since receiving a copy of the initial review, the editorial board takes the manuscript off the register and notifies the author accordingly.
- 5. If author and reviewers meet insoluble contradictions regarding revision of the manuscript, the editor-in-chief resolves the conflict by his own authority.
- 6. The editorial board reaches final decision to reject a manuscript on the hearing according to reviewers' recommendations, and duly notifies the authors of their decision via e-mail. The board does not accept previously rejected manuscripts for reevaluation.
- 7. Upon the decision to accept the manuscript for publishing, the editorial staff notifies the authors of the scheduled date of publication.
- 8. Kindly note that positive review does not guarantee the acceptance, as final decision in all cases lies with the editorial board. By his authority, editor-in-chief rules final solution of every conflict.
- 9. Original reviews of submitted manuscripts remain deposited for 3 years.

It is necessary that all parties participating in the process of publication for the journal Trudy Instituta Russkogo Yazyka imeni V.V. Vinogradova (Proceedings of the V.V. Vinogradov Russian Language Institute), meaning authors, reviewers, members of the editorial team and publisher, to agree upon standards of expected ethical behavior.

The publishing ethics and malpractice policies of the journal Trudy Instituta Russkogo Yazyka imeni V.V. Vinogradova (Proceedings of the V.V. Vinogradov Russian Language Institute) follow the relevant COPE guidelines (http://publicationethics.on>/resources/guidelines) and in case a malpractice is suspected, journal editors will act in accordance with them.

1. Authorship and transparency

By submitting a paper, the authors confirm their authorship of the submitted article. The journal does not require all authors of a research paper to sign the letter of submission. Submission is taken by the journal to mean that all the listed authors have agreed all of the contents.

Those submitting papers should carefully check that all those whose work (in research or writing) contributed to the paper are acknowledged as contributing authors. No one who made a meaningful contribution to the article should be left out and each author should have participated sufficiently in the work to take public responsibility for the content of the article. Funding for any type of publication should be stated within the publication. Other sources of support for publications should be clearly identified in the manuscript, usually in an acknowledgement. Authors should make full acknowledgement of colleagues and other researchers who have made a meaningful contribution to the paper submitted for publication. Authors should ensure that they clearly cite, reference and acknowledge all instances where they have used or been

influenced by the work of others, including their own previously published articles and research material. Any form of plagiarism will not be tolerated.

Self plagiarism (redundant publication) also must be avoided. Authors must inform the editors of the journal about any related papers by any of the authors of the article that have been submitted to other journals.

2. First publication and copyright

Original research articles submitted to the Trudy Instituta Russkogo Yazyka imeni V.V. Vinogradova (Proceedins of the V.V. Vinogradov Russian Language Institute) must not have been published as copyrighted material elsewhere. Manuscripts under consideration by the Trudy Instituta Russkogo Yazyka imeni V.V. Vinogradova (Proceedins of the V.V. Vinogradov Russian Language Institute) should not be submitted for review by other publication. If an article reproduces research material, tables, images, the author must seek permission to use that material and fully acknowledge the owner and/or copyright owner of that material.

By submitting a manuscript, the author agrees that the copyright will be transferred to the Trudy Instituta Russkogo Yazyka imeni V.V. Vinogradova (Proceedins of the V.V. Vinogradov Russian Language Institute) if the manuscript and associated multimedia are accepted for publication. The author retains the rights to the fair use (e.g., teaching and nonprofit uses) of the published material.

3. Dishonesty and libel

Authors must use their best endeavors to ensure the material that they submit contains no fictitious data, reference omissions, or false statements. When the authors discover a significant error or inaccuracy in their own published work, it is the authors' obligation to promptly notify the journal editor and cooperate with the editor to retract or correct the paper. Authors should avoid the use of personal, critical, or disparaging remarks and accusations against fellow researchers, colleagues or other individuals.

4. Peer-reviewing

Reviewers should evaluate manuscripts for their intellectual content without regard to race, gender, sexual orientation, religious belief, ethnic origin, citizenship, or political philosophy of the authors.

The editor and any editorial staff must not disclose any information about a submitted manuscript to anyone other than the corresponding author, reviewers, potential reviewers, other editorial advisers, and the publisher, as appropriate. Reviewers should have no conflict of interest with respect to the research, the authors and/or the research funders. Reviews should be conducted objectively. Personal criticism of the author is inappropriate. Referees should express their views clearly with supporting arguments.

Reviewers should identify relevant published work that has not been cited by the authors. Any statement that an observation, derivation, or argument had been previously reported should be accompanied by the relevant citation.

A reviewer should also call to the editor's attention any substantial similarity or overlap between the manuscript under consideration and any other published paper of which they have personal knowledge.

5. Editors' responsibilities

Editors have sole responsibility for acceptance or rejection of a manuscript. Manuscripts should have peer review, but the editors may reject or accept for cause (inappropriate for journal, clearly of poor quality, contents previously published elsewhere, etc.). Editors should only accept a paper when reasonably certain.

Editors should guarantee the quality of the papers and the integrity of the academic record and be willing to publish corrections, clarifications, retractions and apologies when needed.

Editors should have no conflict of interest with respect to articles they reject or accept.

Editors should preserve anonymity of reviewers.

Editors should ensure that all research material they publish conforms to internationally accepted ethical guidelines.
